

STOP IMPUNITY IN RWANDA AND DR of Congo! DO YOU SUBSCRIBE THIS REQUEST?

RWANDAN PEOPLE PRESUMABLY RESPONSIBLE FOR INTERNATIONAL CRIMES AGAINST CATALAN PEOPLE, SPANISH, RWANDAN, CONGOLESE, CANADIAN, BELGIAN AND BRITISH MUST BE DELIVERED TO JUSTICE!

THREE CATALAN TOWNHALL COUNCILS (those of Figueres, Navata and Manresa) UNANIMOUSLY APPROVED A MOTION BY WHICH THEY URGE THE UNO SECRETARY GENERAL, Mr. BAN KI-MOON AND THE SPANISH PRESIDENT, Mr. JOSE LUIS RODRIGUEZ ZAPATERO, TO TAKE URGENT ACTIONS IN RELATION TO THE INTERNATIONAL CRIMES COMMITTED IN RWANDA AND DR OF CONGO AGAINST SPANISH VICTIMS –AMONG WHICH THERE WERE TWO CATALAN–, RWANDAN AND CONGOLESE BETWEEN 1990 AND 2000. TO ACHIEVE THIS, THE FOLLOWING STEPS SHOULD BE TAKEN:

-Ask the Spanish Government, in virtue of the national legislation and international commitments signed by the Spanish State, that it urges the High Authorities of relevant States to immediate arrest and deliver to the judicial Spanish authorities the 40 prosecuted by the Spanish justice last 6th February 2008, and in particular, the arrest of Major General KAYUMBA NYAMWASA, current fully-empowered Ambassador of Rwanda in New Delhi (India), presumably involved directly in the violent killing of JOAQUIM VALLMAJÓ SALA, as well as of the other Catalan victim, M^a FLORS SIRERA, and other Médicos del Mundo members.

-Ask the European Union, through the Spanish State, that its States members do everything that is legally and conventionally possible to execute, within the European area, the 40 warrants of international arrest resolved by the Spanish judicature.

-Ask the UNO, by means of its Secretary General, that it ceases and separates from their charges in this international organization (in Sudan and Nepal) those people prosecuted by the Spanish justice, and in particular Brigadier General KARENZI KARAKE, Brigadier General WILSON GUMISIRIZA, Captain KARARA MISINGO, Captain FRANK BAKUNZI, and Colonel CHARLES KARAMBA.

-Ask the UNO, by means of its Secretary General, in virtue of those applicable international commitments, that necessary steps be taken so that the people above referred to, who have been judicially prosecuted and work for the UNO, be delivered to the International Organization of Criminal Police, Interpol, to due legal effects.
